# **TERMS AND CONDITIONS**

## 1 Payments:

Registration fee will be paid when enrolling. The rest will be paid 30 days prior to the beginning of the course. Failure to do so will result in the cancellation of the course.

The course price includes the activities detailed in the leaftlet. Any other extra activity will be paid separately.

By signing the registration form, the pupil or guardian is committed to pay the remaining amounts prior to departure. YIC reserves the right to cancel the course if this requirement is not fulfilled 30 days before the beginning of the course. If so, YIC will be keep the amounts previouly received as compensation and as a penalty clause.

The enrollment to the program will not be complete until YIC receives all payment, forms and confirms the registration. In the case that YIC could not carry out the program for any reason and all payments and forms have been completed, YIC will offer an alternative option. If an agreement is not reached, the total amount of money paid up to that momento will be refunded. In this case, the student or legal guardian will waive the right to any claim or compensation.

If course registration is finalized less than 30 days prior to the beginning of the course, the payment must be paid in full.

Flights organized by YIC will be accompanied by a YIC representative at all times. YIC will arrange flights, dates and meeting points. YIC acts as an intermediate for any transportationc company that is used. Thus, YIC will not be held responsible for any incidences that may arise such as accidents, flight cancellations, flight delays, lost or damaged luggage, etc.

If the student does not depart with the organization, the costs incurred due to flights and transportation will be paid for by the student or legal guardian.

## 2 Cancellation:

In the case of student cancellation, the student or guardian must submit a written cancellation request. For all intents and purposes, the reception date of this document will be taken as a reference to count the arranged deadlines and the following expenses will be incurred by the student/ guardian:

• Any date before departure, 100% of the fees.

- Between 30 and 16 days before departure, 100% of the fees and 25% of the rest of the paid amounts.
- Between 15 and 2 days before departure, 100% of the fees and 75% of the rest of the paid amounts.
- The day before departure, the departure day or the days following the departure, 100% of the paid amount will not be refunded.

YIC reserves the right to cancel the contract in the following circumstances:

- A. If the information on the registration form is misleading or not true or accurate.
- B. If the participant breaks the law in the country where the program is being held
- C. If the participant does not comply with the health regulations established by the country where the camp is being held.

D. If the participant or legal guardian does not pay the program fees before the agreed dates.

All charges incurred due to these circumstances will be paid for by the student or guardian, without any compensation or refund.

Both parties reserve the right to cancel the signed contract after the start of the program due to health issues or any circumstance which may impede the correct participation in the program.

## 3 Health and medical issues:

The student or legal guardian guarantees that he/she does not have any medical issues which could impair from participating in any sports activity.

If a student has or has had any mental or physical health issue that requires medical treament, has any allergies or requires any special diet, the Organization must be informed when enrolling in the program.

Prescription medication may be taken for medical reasons and always under adult supervision. Any medical treatment must be disclosed to the Organization prior to departure.

YIC will not be held responsible if all medical issues are not disclosed upon enrollment.

#### 4 Insurance coverage:

Insurance coverage is mandatory for any student enrolled in the program. Coverage, provided by Europ Assistance, is included in the price of the program for Spanish residents. Yic also offers insurance coverage for non Spanish residents at an extra cost.

Student/guardian will be responsible for anything not covered by the insurance. The insurance policy will be available upon request.

## 5 Modification of services :

The student or legal guardian relinquishes the right to place a claim against YIC, its employees and any person related or working on behalf of the Organization for any direct imputable act such as lesions, sickness, injury, accidents, delays, irregularities or costs incurred due to strikes, war, weather, quarantine, government restrictions, natural catastrophes, or any modification due to airlines, ferries, trains, buses, general transportations, hotels, restaurants, any service company or any person pertaining to the above mentioned.

YIC has the right to modify the program if there is any reason to do so. If any activity should not be carried out, an alternate activity will be offered. The student or legal guardian waives the right to place a claim for the refund of the original activity since there will be an alternative.

YIC reserves the right to cancel the program or the enrollment of a student. The amount paid up to the momento of cancellation will be refunded to the student or legal guardian with the exception of the cost of the flights. The student or legal guardian waives the right to place a claim for a refund.

 $\operatorname{YIC}$  reserves the right to modify the program dates as well as the prices due to external causes.

## 6 Price modification:

YIC reserves the right to modify the program dates as well as the prices due to external causes.

If an increase in the price of transportation, taxes, or other charges should occur unexpectedly, the cost of the program may increase accordingly. This will be notified 20 days prior to departure.

#### 7 Code of conduct:

Any student enrolled in the program will be held accountable by Irish laws. Any infraction of the law will result in the immediate suspension of the student and he/she will be held solely responsible.

All charges incurred due to a violation of the law, such as flights, transportation and cancellations, will be paid for by the student or guardian.

If the student does not follow the Organization's behavioral policy or violates the rules, YIC holds the right to suspend the course and send the student back home. All charges incurred due to this suspension such as flights, transportation and cancellations, will be paid for by the student or guardian, without any compensation or refund.

The consumption, purchase, possession of energy drinks, alcohol or any illegal substance for personal use or for third parties is strictly prohibited.

Smoking and vaping is strictly prohibited for students under 18.

Any student that violates these policies will be suspended and sent home. All charges incurred due to this suspension such as flights, transportation and cancellations, will be paid for by the student or guardian, without any compensation or refund.

Prescription medication may be taken for medical reasons and always under adult supervision. Any medical treatment must be disclosed to the Organization prior to departure.

### 8 Liability limit:

YIC will not be held liable for any injury or damage incurred during activities not included in the program as well as any damage suffered from the misuse of material, facilities or due to violating the code of conduct.

### 9 Jurisdiction clause for claims:

YIC will respond to any written claim before the termination of the program.

By enrolling in the program, the student/legal guardian accepts and acknowledges each of the conditions stated above .

All conditions are subject to the court of law from Madrid. Therefore, any law outside the jurisdiction will not be upheld.
